

### **TEACHING AGREEMENT & INVOICE**

Thank you for your interest in my work. This agreement is made between Mel Beach (Artist/Teacher) and (Venue/Organization) for the following services:

Audio/video recording is not permitted, nor photographs of my slideshow presentation. Photography of quilts during trunk show portion is permitted and encouraged, with artist's credits included if sharing/posting.

Each workshop is designed to include 6 hours of instruction for 20 students max. Please ensure venue provides well-lit workspace for sewing machine set up/use, as well as has ample space for me to easily walk about the room and consult with participants on an individual basis.

- 1-2 quilt racks to display quilts
- 2-3 Irons & boards for student use

### Expenses

Expenses to be provided, paid for and/or reimbursed to Mel Beach for the following:

In the case of international travel and teaching contracts, there may be special considerations.

Payment for teaching fees and expenses will be paid to Mel Beach before the end of last teaching day (invoice/receipts to be provided by Artist/Teacher)

# Cancellations

Cancellations may be made by either party 60 days from teaching engagement or prior to expenses incurred by Artist/Teacher. If conditions beyond our control (ie. National/local emergency, pandemic, weather emergency, illness, accident, flight cancellations and/or serious family emergency, etc) prevent Mel from teaching or lecturing, it is agreed that this contract may be terminated without a penalty payment assessed by either party. Offering an online program and/or rescheduling the program may be an option. If Venue/Organization terminates the contract after the purchase of non-refundable airline tickets, the organization will compensate the teacher/artist for the price of the ticket or pay the change/cancellation penalty.
